SUBJECT: NRC INSPECTION OF AEROTEST OPERATIONS, INC.

This letter refers to the special, announced inspections of your activities authorized under NRC License Number R-98. These inspections were conducted by L. Norderhaug and P. Qualls of this office on January 3 - 11, 1994. This letter also refers to the discussion of the preliminary inspection findings with R. Tsukimura and other members of your staff on January 11, 1994.

Areas examined during this inspection visit are described in the enclosed inspection reports (Enclosure A -- reactor operations and Enclosure B -- physical protection and material control and accounting). Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Within the scope of these inspections, no violations or deviations were identified.

In accordance with Section 2.790(a) of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and Enclosure A will be placed in the NRC Public Document Room.
