SUBJECT: NRC INSPECTION REPORT NO. 50-443/93-22

This letter transmits the report of the safety inspection findings of the resident staff at Seabrook Station for the period of December 7, 1993, through January 17, 1994. The inspection consisted of document reviews, personnel interviews, and observations of activities important to the health and safety of the public. The inspector discussed the findings with Mr. W. DiProfio and members of your staff after the inspection.

Overall, this inspection found that activities were conducted safely. We found that your personnel error response team (PERT) performed a comprehensive and self-critical review. The PERT effort seems to be a reasonable method to reduce the number and significance of personnel errors. The implementation and measure of the effectiveness of the PERT recommendations merit your continued attention to ensure the success of the PERT effort. After completion of the first PERT effectiveness review, I propose that a management meeting be held in the Region I office. At the meeting, please be prepared to discuss the results of the first PERT effectiveness review and the longer term aspects of the PERT effort. Please work through the Projects Section Chief to arrange the meeting at an appropriate time.


