

SUBJECT: NRC INSPECTION REPORT 030-32627/94-01

This refers to the initial, announced inspection conducted by Messrs. William H. Radcliffe and Gilbert L. Guerra, Jr. of this office on February 7, 1994. The inspection included a review of activities authorized by Byproduct Materials License 25-27425-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress. The inspectors reviewed records generated in conjunction with the use of a blood irradiator containing 2,463 curies of cesium-137.

During this initial inspection, the inspector discussed with your staff the requirements with which you must comply, including the NRC and Department of Transportation regulations, and the commitments in your license application. The NRC enforcement policy was also discussed at this time.

No violations or deviations were identified; therefore, no response to this letter is required.

In accordance with 10 CFR 2.790 of the MRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
