As discussed in Chapter 4 of the DEIS, the NRC has determined that the construction and operation of the CISF would not adversely affect historic properties near the site. In support of this determination, the NRC staff conducted a site visit, reviewed available archaeological literature, conducted a search and evaluation of archaeological records and collections maintained by the New Mexico State Historic Preservation Office (NM SHPO) and U.S. Bureau of Land Management. Documentation of tribal consultation is presented in Appendix A of the DEIS. The updated Class III Report, along with the NRC staff recommendations, will be submitted to the NM SHPO for concurrence prior to finalization of the DEIS. While consultation under NHPA Section 106 is ongoing, the NRC staff's preliminary conclusion is that no historic properties would be affected by the proposed action.
