This acknowledges receipt of your June 16, 1982 letter which transmitted changes to the LaSalle County Station, Units 1 and 2, Security Plan.

We have reviewed the changes and agree that several of the changes discussed in the above referenced letter are consistent with the provision of 10 CFR 50.54(p). Other changes are in need of minor administrative correction, with additional clarification required. We do not agree with some other changes for substantive reasons, since they appear to decrease the effectiveness of security. The enclosure to this letter provides information regarding these points. Please revert to the previously approved plan wording or, if desired, modify your plan to accomodate the attached comments. Resubmit corrected plan pages as necessary to maintain plan continuity.

We have determined that the above referenced letter and the enclosure to this letter contain Safeguards Information of a type specified in 10 CFR 73.21 and is therefore being withheld from public disclosure.
