The purpose of this modification is to increase the task order ceiling as a result Parameter Inc.'s revised cost proposal dated December 1, 1993 and the attached modification to Statement of Work. In accordance with Section G.4, Task Order Procedures, of the subject contract, this letter definitizes Task Order No. 05, Mod. 1.

This modification increases the cost ceiling by \$4,444.00 from \$27,888.04 to \$32,332.04. The amount of \$31,557.80 represents the estimated reimbursable costs, the amount of \$54.00 represents the facilities capital cost of money, and the amount of \$720.24 represents the fixed fee. The amount presently obligated as a result of this modification is \$4,444.00.

The issuance of this modification does not amend any terms or conditions of the subject task order or the basic contract contract.


