This confirms verbal authorization to Parameter, Inc. on October 26, 1993 to modify the subject task order to change the place of review and to provide additional funding in the amount of \$1,231.92 increasing the total amount obligated for this task order from \$52,456.90 to \$53,688.82. The effort shall be performed in accordance with the enclosed modification to the Statement of Work and Parameter Inc.'s technical proposal dated October 26, 1993 incorporated herein by reference.

The period of performance October 8, 1993 through November 19, 1993 remains the same. The revised cost ceiling is \$53,688.82. The amount of \$52,194.02 represents the estimated reimbursable costs, the amount of \$85.71 represents the facilities capital cost of money, and the amount of \$1,409.09 represents the fixed fee. The total amount obligated under the basic contract for this task order is \$53,688.82.


