In order to expedite the lease with Clevite, in response to a teletype from them, we sent Special Nuclear Material Order Forms for completion. In our letter of January 24, 1958, a copy of which is enclosed, we stated that upon receipt and acceptance of the se forms and notification from AEC Headquarters that Clevite is appropriately licensed to receive and possess this material, we would place their order with our contractor. In their letter dated February 3, 1958, a copy of which is also enclosed, returning the Special Nuclear Material Order Forms, Clevite submitted partial shipping instructions for the material and stated that, during discussions with ALC Headquarters on January 28, they were advised that the ALC would place orders for processing of material even though the applicant may not yet have been granted a license to receive and possess the material. If the order is placed and the metal processed prior to the granting of the license including approved shipping instructions, we will be unable to package or ship. This could result in having to store the material and possibly repackage it incurring additional costs and work and also extra paper work necessary to send supplemental instructions to the contractor. We prefer to execute agreements and place orders with our contractors for the work only after all conditions have been met. In this manner, commercial orders are all handled on an equal basis. We have found that the commercial firms understand and accept the basis of "first come - first served".
