In accordance with Section G.5 entitled, "Task Order Procedures" of the subject contract, this letter definitizes Modification No. 2 to Task Order No. 2 for performance of additional work on the Preliminary Rulemaking Package, as described on page 15 of Sanford Cohen & Associates' letter dated November 12, 1993 (copy attached).

Accordingly, the task order is hereby modified as follows:

The level of effort is increased by 290 staff hours and the task order ceiling is increased to \$402,387.73.

The second paragraph of the definitization letter of the basic task order, third sentence, is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 2 shall be in effect from February 12, 1993 through February 12, 1995, with a total cost ceiling of \$402,387.73. The amount of \$375,843.00 represents the total estimated reimbursable costs and the amount of \$26,544.73 represents the fixed fee."

The issuance of this task order does not amend any other terms or conditions of the subject contract.




