The reference letter outlined the BWR Owners' Group (I VROG) position and desire to cooperate with the NRC in meeting the NRC's information and communication needs with regard to BWROG reactor water level reference leg testing results. In the reference letter, the BWROG committed to provide a report of the de-gas testing results by January 14, 1994. Enclosed with this letter is that report.

The enclosed report contains a summary of the testing objectives, test program and general conclusions regarding the de-gassing phenomena in reactor water level reference legs. In the spirit of continued cooperation with the NRC, but without setting any precedent relative to the dissemination of proprietary information, the BWROG and EPRI have decided to waive their commercial interest in the report and the test data previously provided to the NRC. Therefore, this report and the test data may be used internally and released to the public by the NRC.

In earlier conversations with the NRC Staff, the Staff indicated it may decide to also make publicly available other information and data collected either from EPRI's

subcontractor in Princeton, NJ, or telecopied to the NRC. As stated in the reference letter, if the Staff does decide to release this additional information, it will only be made available as an attachment to the enclosed report.

Each member must formally endorse a BWROG position for that position to become that member's position.
