Revision of the Station Annex to Generating Stations Emergency Plan

Reference: (1) G. Dick (USNRC/NRR) letter to D. L. Farrar (Commonwealth Edison) dated December 23, 1994.

Enclosed are the revisions to the Generating Stations Emergency Plan (GSEP) for each PWR Station Annex (Attachments 1 through 3; BRW-94-01, BYR-94-01 and ZIN-94-01). The Station Annex pages affected by the changes are attached and changes are identified with shading.

The addition of Core Exit Thermocouple readings for the Fuel Clad Fission Product Barrier criteria 2.a meets the commitment documented in Reference (1). In addition, Zion Station replaced Spent Fuel racks which lowered the spent fuel by 1 1/2 inches. In order to reflect the Technical Specification level requirement (22 feet above top of fuel), MU11 was revised from 613 feet 1 1/2 inches to 613 feet 0 inches to account for the lowering of the spent fuel. Pending your approval, implementation of the changes will be made during the week of 14 March 1994.

The changes to the GSEP Annex have been reviewed in accordance with Commonwealth Edison procedures by the Onsite and Offsite Review groups. These reviews have concluded that the changes to the GSEP Annex do not decrease the effectiveness of the plan.
