Per our conversion earlier today, I am enclosing a copy of "ORDER REVOKING LICENSE" dated November 25, 1993, from Mr. Ronald M. Scroggins, Deputy Chief Financial Officer/Controller. I am also enclosing a copy of a new invoice that I received recently. As stated in my letter dated June 23, 1993, which was copied to you, I reiterate that I never had a Nuclear Medicine Laboratory in my office, which was originally located at 1559 West Big Beaver Road, Building E, Troy, Michigan, 48084, which was completely destroyed in a fire in November 1990. Also, since I moved to my new office in December 1990, I have not had any Nuclear Medicine Laboratory at this location either. As I have consistently stated earlier, if applicable laws allow me to maintain a Nuclear Medicine License without actually maintaining a Nuclear Medicine Laboratory, I will be willing to pay the minimum required license fee to do just that and no more.

I also again reiterate that the amounts on the statements received from NRC, are not owed in view of the facts stated in this letter and the letter of June 23, 1993. I hence respectfully submit that you and the various departments at NRC should immediately correct the errors in all the records and please notify me that this corrective action has indeed been taken and that all the erroneous amounts owed have been completely removed from all your files and records and that of all the various departments at NRC.

In response to your communications, the copies of which are enclosed herewith, I am informing you that on numerous occasions I have informed the various departments of Nuclear Regulatory Commission that I have never had a Nuclear Medicine Laboratory in my office, which was originally located at 1559 West Big Beaver Road, Bldg. E, Troy, Michigan. 48084, which was completely destroyed in a fire in November 1990. Also, since I moved to my new office at 1777 Axtell Road, Suite 104, Troy, Michigan, 48084, in December 1990, I have not had any Nuclear Medicine Laboratory at this location either. I have consistently informed NRC that all that I may owe is a fee to maintain my Nuclear Regulatory License and not to maintain a Nuclear Medicine Laboratory. I was informed by NRC more than a year ago that my Nuclear Regulatory Commission license was also terminated.

By this letter I am informing you that the amounts stated on your statements are not owed in view of the above stated facts. I submit that you and NRC immediately correct these errors in your records and send me a letter indicating that this corrective action has been taken with retrospective effect, and that the erroneous amounts owed have been completely removed from all your files and records and that of NRC, relative to this account. I also ask that such an action should be taken immediately and without any further delay sice this has not been done for several years inspite of this information having been provided to NRC in several communications.
