This refers to the routine safety inspection conducted by Mr. C. Petrone of this office on July 19 - 22, 1982 at Beaver Valley Power Station, Unit No. 1 of activities authorized by NRC License No. DPR-66 and to the discussions of our findings held by Mr. Petrone with Mr. M. Coppola of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter.
