SUBJECT: COMBINED INSPECTION REPORT NOS. 50-220/94-02 AND 50-410/94-02

This letter refers to the announced inspection conducted by Ms. L. Kay of this office on January 24-28, 1994, at the plant site in Scriba, New York. The inspection included a review of activities authorized for Nine Mile Point Nuclear Station, Units 1 and 2. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

The inspection was directed toward areas important to public health and safety to determine whether activities authorized by the licenses were conducted safely and in accordance with NRC requirements. Within these areas, the inspection consisted of selected examinations of procedures and records, interviews with personnel, and observations by the inspector.

The areas examined during this inspection focused on review of the overall adequacy and implementation of your fire protection program. The inspector reviewed administrative controls governing combustibles, fire risk maintenance evolutions, and fire control capabilities including fire detection and suppression systems.

During this inspection, an unresolved item was identified regarding future assignment of fire brigade members. This item requires further NRC review following implementation of organizational staff changes to verify full brigade response to alarms and no responsibility conflicts exist between the emergency plan for Nine Mile and brigade member duties.
