2.206 PETITION

Your August 6, 1982 memorandum identified NRR staff requirements to be met before issuing a full power amendment to the La Salle Unit 1 operating license. These included two licensing conditions related to the HVAC system and action on the 2.206 petition by Mr. E. M. Gogol. The following describes our actions taken with these requirements.

On August 6, 1982, I acted upon Mr. Gogol's petition; a copy of my determination is enclosed as Attachment 1.

On August 13, 1982 a full power amendment was issued which included the two license conditions identified in your August 6 memorandum (Attachment 2). With respect to the license condition which restricted power to 5 percent, the staff concluded that the matter was resolved to its satisfaction on the basis of the licensee's August 11, 1982 submittal and lifted the 5 percent power restriction. A copy of the staff's August 13 letter lifting the license condition is enclosed as Attachment 3.
