Subject: HNDC HN-100 Series 3 and 3A Radioactive Materials Package Certificate of Compliance No. 71-9151

Dear Mr. MacDonald:

Reference is made to our letter of July 15, 1982, which requested that Certificate of Compliance No. 71-9151 be revised to include the HN-100 Series 3A cask, an upgraded version. In addition, it is requested that the revised certificate include the latest "as-built" drawing for the HN-100 Series 3 casks. Eight copies of Hittman Nuclear & Development Corporation Drawing Nos. C001-5-9138, Rev. 7 and C001-5-9140, Rev. 5, are attached. Attachment A contains a listing of the changes included in the drawings and the requested revisions in the Certificate of Compliance.

Our letter of July 15, 1982 forwarded a check in the amount of \$150 to cover the revision to the Certificate of Compliance. ATTACHMENT A

Radioactive Material Package Revision of Certificate of Compliance HNDC Model HN-100 Series 3 Docket No. 71-9151

August 12, 1982

A. GENERAL

This application covers the submittal of two revised drawings to reflect the "as-built" dimensions of the HN-100 Series 3 casks.

B. Drawing Changes

The changes in the Hittman Nuclear & Development Corporation Drawings are as follows:

C001-5-9138, Rev. 7

The length of the bolts (Items 16 & 19) used to attach the ratchet binder to the cask body and cover have been increased.

A detail has been added to show the proper splice to be used on the cover and shield plug gaskets (Items 4 & 5).

C001-5-9140, Rev. 5

The dimensions on the cover tie-down brackets have been changed to show fabrication tolerances.

C. Requested Changes to Certificate of Compliance No. 71-9151

It is requested that Certificate of Compliance Number 71-9151 be revised as requested in Paragraph E of Attachment A to HITTMAN letter dated July 15, 1982 except:

Paragraph 5(a)(3)

"The Series 3 packaging is fabricated in accordance with Hittman Nuclear & Development Corporation Drawing Nos.: C001-5-9138, Rev. 7; C001-5-9139, Rev. 4; C001-5-9140, Rev. 5; C001-5-9141, Rev. 2; C001-5-9142, Rev. 1; C001-5-9143, Rev. 5; and C001-5-9144, Rev. 3."
