

Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding or any request for an extension of the 10 day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
