Subject: Inspection 50-29/82-08

This refers to the routine resident safety inspection by Mr. S. Collins on July 9-30, 1982 at the Yankee Nuclear Power Station, Rowe Massachusetts. The inspection consisted of document reviews, interviews, measurements, and observation of activities, and the results have been discussed with Mr. H. Audio of your staff.

An apparent Violation of NRC requirements is cited in Appendix A and categorized by level in accordance with Federal Register Notice (47 FR 9987), dated March 9, 1982. A reply is required and should be prepared in accordance with Appendix A. It is exempt from the Office of Management and Budget's clearance procedures under the Paperwork Reduction Act of 1980, PL 96-511.

Appendix A, pages 5 thru 6 of the enclosed report contain physical security information which will be disclosed only in accordance with 10 CFR 9.12. The rest of this transmittal will be made public unless you contact us about, and then apply in writing for, withholding within 10 and 30 days, respectively, of the date of this letter. Such application must comply with 10 CFR 2.790 (b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
