Subject: Combined Inspection 50-277/82-14, 50-278/82-14

This transmits the findings of the routine resident safety inspection by Mr. A. R. Blough on July 1 - August 6, 1982 at the Peach Bottom Atomic Power Station, Delta, Pennsylvania. These findings were based on observation of activities, interviews, and document reviews, and have been discussed with Mr. W. T. Ullrich of your staff.

An apparent violation of NRC requirements is cited in Appendix A and categorized under the NRC Enforcement Policy, 10CFR2 Appendix C (47FR9987, March 9, 1982). A reply is required and should be prepared in accordance with Appendix A. It is exempt from the Office of Management and Budget's clearance procedures under the Paperwork Reduction Act of 1980, PL 96-511.

In addition to the Notice of Violation forwarded herewith, two apparent violations, failure to follow Technical Specification Limiting Conditions for Operation for protective instrumentation and failure to properly line-up the back-up air supply to the Automatic Depressurization System, are detailed in the enclosed report. These items will be further reviewed and will be forwarded under separate correspondence.

In accordance with 10CFR2.790(a), a copy of this letter and enclosures will be placed in the NRC Public Document Room, unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of this letter. Such application must be consistent with the requirements of 10CFR2.790(b)(1).
