Subject: Combined Inspection 50-272/82-19, 50-311/82-19

This refers to the routine resident safety inspection by Messrs. L. Norrholm and R. Summers on August 4-31, 1982 at the Salem Nuclear Generating Station, Hancocks Bridge, New Jersey. The inspection consisted of document reviews, interviews, and observation of activities. The findings were discussed with Mr. H. J. Midura of your staff.

An apparent violation of NRC requirements is cited in Appendix A and categorized under the NRC Enforcement Policy, 10 CFR 2 Appendix C (47FR9987, March 9, 1982). A reply is required and should be prepared in accordance with Appendix A. It is exempt from the Office of Management and Budget's clearance procedures under the Paperwork Reduction Act of 1980, PL 96-511.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
