CHAIRMAN PALLADINO: Please come to order. Good morning, ladies and gentlemen. This is an affirmation session and there is one item on the agenda for this session and I am going to ask the Secretary to introduce the topic.

MR. CHILK: Mr. Chairman, we will need a short notice vote to affirm this matter, if I could ask the Commission.

CHAIRMAN PALLADINO: May I have a short notice vote?

(Chorus of unanimous ayes.)

MR. CHILK: The affirmation is 82-372 which is a revision of a previous order, CLI-82-21, to give additional delegation of authority to the director of NMSS to appoint hearing officer to conduct informal hearings.

On August 6th, the Commission issued an order which authorized the NRC staff to conduct an informal hearing concerning the Kerr-McGee license for its West Chicago Rare Earths Facility, and under the terms of that order, NMSS was authorized to conduct a hearing, the director was, himself, or to delegate that responsibility to any of his Division Directors or Branch Chiefs. In this paper, the Commission is being asked to expand that authority to delegate to include the Deputy Director of NMSS and the Deputy Division Directors.

The Chairman, Commissioners Ahearne, Roberts and Asselstine have approved the order. Commissioner Gilinsky has disapproved it.

Would you please affirm your votes?
