Dear Mr. Hickey:

This is in further response to your letter dated July 26, 1982, in which you requested, pursuant to the Freedom of Information Act, copies of the tape recordings of interviews with Floyd Oltz on February 25 and June 4, 1981 and any other tape recordings made during the course of the Zimmer investigation.

In addition to the tapes sent to you on August 6, 1982, enclosed are three tapes of a meeting between the Government Accountability Project and NRC Region III on February 26, 1981; and one tape of an interview with Rex Baker on March 3, 1981.

As explained to you in a telephone conversation with Carol Ann Reed, part of one of the February 26, 1981 tapes was damaged by NRC during the duplication process. Therefore, we have also enclosed a transcript of that meeting with the missing portion of the tape bracketed.

One additional tape recording is still undergoing review. As soon as that review is completed, we will be in touch with you.
