During the week of April 19, 1982, Duke Power Company and Westinghouse met with the NRC's Mechanical Engineering Branch to resolve open items relative to the Catawba FSAR. Item 109 concerning fuel damping values was discussed at the meeting and was subsequently resolved. The minutes of the meeting which document resolution of Item 109 are attached for your information and use. Please note that minutes from the remainder of the meeting were transmitted to the Staff by my letter of September 27, 1982.
