Gentlemen:

This refers to the inspection conducted by Mr. J. R. Costello of this office and Dr. P. T. Kuo of USNRC/ONRR on July 12-15, 1982, of your facility at San Francisco, California, and to the discussions of our findings with Mr. F. A. Hollenbach and members of your staff at the conclusion of the inspection.

This inspection was made as a result of concerns expressed to NRC by a former Bechtel employee concerning the hydrodynamic load analysis performed by Bechtel on the Susquehanna and Limerick facilities.

Areas examined during this inspection and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, we found no instance where you failed to meet NRC requirements.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room. If this report contains any information that you believe to be exempt from disclosure under 10 CFR 9.5(a)(4), it is necessary that you (a) notify this office by telephone within 10 days from the date of this letter of your intention to file a request for withholding; and (b) submit within 25 days from the date of this letter a written application to this office to withhold such information.
