AFFIDAVIT OF THOMAS C. BORDINE

My name is Thomas C. Bordine. My business address is 1945 W. Parnall Road, Jackson, Michigan. I am employed by Consumers Power Company as a Staff Licensing Engineer for the Big Rock Point Plant. My duties in that position include responsibility for the coordination and response of licensing activities related to the Big Rock Point Plant.

The purpose of this affidavit is to acknowledge two commitments made by Consumers Power Company to the NRC Staff with regard to the Big Rock Point Plant. These commitments were noted by the NRC Staff witnesses in the course of their testimony submitted in response to O'Neill Contention IIC, the cask drop issue.


The commitments are as follows:

1. Consumers Power Company has agreed to upgrade the visual acuity requirement for its crane operators at the Big Rock Point Plant to comply with the standards of ANSI B30.2 - 1976 "Overhead and Gantry Cranes". Qualification of crane operators will thus include visual


testing by that standard at the time of initial or renewal certification.

2. Consumers Power Company agreed to cross reference Maintenance Procedure MFHS-1 "Transfer Cask - Preparation for Fuel Movement" with Maintenance Procedure MFHS-4 "Test Tripping and Resetting of Fuel Handling Transfer Cask." This cross referencing has been completed. MFHS-1 now requires that the safety sling trip test be performed prior to each time the spent fuel transfer cask is prepared for movement of spent fuel.


