Enclosed is a report of an inspection conducted by Mr. A. Della Greca of this office on June 25-29, 1990, of activities at the James A. Fitzpatrick Nuclear Power Plant. These activities are authorized by NRC Operating License No. DPR-59. Discussions of our findings were held by Mr. Della Greca with you and members of your staff at the conclusion of the inspection.

Specific areas examined during this inspection included your compliance with the orders issued to implement R.G. 1.97 and are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel and observations by the inspector.

Based upon the results of this inspection, it appears that one of your activities was not conducted in accordance with your commitment regarding power transfer equipment as set forth in the Notice of Deviation, enclosed herewith as Appendix A. You are requested to respond to this letter and, in preparing your response, you should follow the instructions in Appendix A.

Your cooperation with us in this matter is appreciated.


