The purpose of this modification is to provide incremental funding in the amount of \$454,000.00. Accordingly, the contract is hereby revised as follows:

1. Under Section B - Supplies or Services and Prices/Cost, Paragraph B.2. Consideration and Obligations, subparagraph b, the first sentence is deleted in its entirety and the following sentence is substituted in lieu thereof:

"b. The amount presently obligated with respect to this contract is \$5,360,000.00."

All other terms and conditions, including the contract ceiling of \$8,920,281.00, remain unchanged.
