AMENDMENT NO. 12 TO SOURCE MATERIAL LICENSE SUA-917 FOR

THE MOAB MILL

By letter dated November 14, 1989, Atlas Corporation requested amendment of Source Material License SUA-917 for a change in the organizational structure affecting the Moab Mill. Atlas Corporation's previous organizational structure had positions based in Princeton, NJ and Grand Junction, CO. These positions have been relocated to Denver, CO and Moab, UT. The new organizational structure is streamlined, eliminating the President of Minerals Division and the Vice President of Finance. Other positions within the old organizational chart have had title changes except for the Radiation Control Coordinator and the Moab Operations Coordinator.

A review of Source Material License SUA-917 indicates that only minor changes to License Condition No. 11 are necessary to reflect the new organizational structure. License Condition No. 11 references Atlas' submittal of January 26, 1988 which outlines the old organizational structure. The submittal date of January 26, 1988 will be dropped from License Condition No. 11 and the replacement submittal date of November 14, 1989 will be referenced in its place.

The staff concludes that License Condicion No. 11 should be revised to reference the November 14, 1989 letter from Atlas Corporation and that the referenced submittal date of January 26, 1988 be deleted. The staff therefore recommends that Source Material License SUA-917 be amended by revising License Condition No. 11 to read as follows:

11. For use in accordance with statements, representations and conditions contained in Section 4.2.4, 5 and 7 (except 5.5.10 and 5.5.11) and Appendices 5.3, 5.5.6, and 6.0 of the licensee's renewal application dated May 31, 1984 and submittals dated December 17, 1984, January 18 and June 5, 1985, December 4, 1986 and November 14, 1989.

Whenever the word "will" is used in the above referenced sections it shall denote a requirements.
