The purpose of this modification is to provide partial funding for the guaranteed minimum under the contract. Accordingly, the following changes are made:

1. Paragraph b. of Section B.2 is hereby completed as follows:

"b. The amount presently obligated with respect to this contract (exclusive of amounts previously obligated on task orders issued under this contract) is \$379,000.00. This obligated amount represents partial funding of the guaranteed minimum amount of the contract (See Section H.9). Individual task orders shall state whether funds for that effort are being obligated on the task order or have been previously obligated on the contract."

All other terms and conditions, including the ceiling amount of \$2,647,815.00, shall remain the same.
