A routine, safety inspection of your emergency preparedness program and annual emergency preparedness exercise was conducted by Mr. E. Fox of this office and other members of an NRC team on August 6 to 10, 1990 at your Calvert Cliffs Nuclear Power Plant, Lusby, Maryland. Discussions of our findings were held by Mr. Fox with you and members of your staff at the conclusion of both the exercise and the inspection.

Areas examined during this inspection are described in the NRC Region I inspection report which is enclosed with this letter. Within these areas the inspection consisted of selective examination of procedures and representative records, interviews with personnel and observations of the emergency exercise by team members.

Within the scope of this inspection, no violations or deviations were identified. Although exercise weaknesses were identified, Baltimore Gas and Electric's performance during the exercise demonstrated the ability to implement the Calvert Cliffs Nuclear Power Station Emergency Plan and Implementing Procedures in a manner that would provide adequate protective measures for the health and safety of the public.
