Introduction

On September 5, 1990, the Transportation Branch Staff (staff) met with representatives of Babcock and Wilcox Company (B&W) to discuss renewal of Certificates of Compliance Nos. 5341, 5910 and 6357. These certificates are under timely renewal. However, the deadline for submitting a consolidated application for each package expired on September 1, 1990. B&W is requesting that the deadline be again extended.

Discussion

The following items were discussed in the meeting:

B&W will submit a consolidated application for renewal of Certificate of Compliance No. 6357 for the Model No. NNFD-10 package. The designation of the certificate will be changed from B() to AF. The package, which is a DOT Spec. 6M package, will not be used to ship uranium compounds in powder form.

Certificate of Compliance No. 5341 for the Model No. NFP-55, also a DOT Spec. 6M package, allows shipment of uranium compounds in powder form. B&W will redesign the package and apply for a new Certificate of Compliance. B&W requested that the current certificate be renewed for a period of

approximately 2 years to allow for the design, testing, licensing and fabrication of the new package.

To support renewal of Certificate of Compliance No. 5910 for the Model No. NNFD-SA-2, B&W will submit drawings, operating procedures and maintenance program for the package.

The following items were discussed during follow-up telephone conversations between the staff and B&W: (1) B&W will submit a consolidated application for renewal of Certificates of Compliance Nos. 6357 and 5910 by November 1, 1990; (2) B&W will submit an application for renewal of Certificate of Compliance No. 5341 for a period of 18 months by November 1, 1950; and (3) B&W will submit an application for certification of the new package design by the end of this 18-month period.
