Subject: Implementation of Regulatory Guide 1.97 for Haddam Neck

This letter confirms the dates of October 1-5, 1990 for Regulatory Guide 1.97 inspection at the Haddam Neck Plant. Our plans for this inspection were discussed with your staff during a telephone call between Mr. Paul Blasioli of your organization and Mr. Leonard Cheung of the NRC Region I office. The inspection will take place at the Corporate Office in Berlin, Connecticut and at the Haddam Neck Plant site in Haddam, Connecticut.

A management entrance meeting is scheduled for 2:00 p.m. on October 1, 1990. The management exit meeting is tentatively scheduled for October 5, 1990 at 11:00 a.m.

For this inspection we will require the following:

1. Calibration Records for Category 1, type A, B and C variables
2. Loop Diagrams and Schematics
3. P&IDs
4. Power Source Diagrams
5. Diagram of Control Room Panel (location of instruments)
6. EQ Master List

The above information is to be made available at the inspection site on October 1, 1990.

We will require one copy of the list of the Category 1, type A, B & C variables for the Haddam Neck Plant one week prior to the inspection.
