Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

The purpose of this modification is to: (1) extend the 800 service through December 31, 1990, (2) increase contract ceiling amount, and (3) insert the Clause 52.232-18, entitled, "Availability of Funds." Accordingly, the contract is hereby modified as follows:

1. Under Section B.1, Consideration and Obligation, paragraph a., the first sentence is deleted in its entirety and the following sentence is substituted in lieu thereof:

"a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$224,500.00."

NOTE: This modification is subject to the availability of fiscal year 1991 funding which is in accordance with the contract Clause 52.232-18.

2. Under Section F, Deliveries and Performance, subsection F.1, Duration of Contract Period, is revised to read as follows:

"This contract shall commence on February 18, 1987 and end on December 31, 1990. The contractor shall provide 800 service commencing March 1, 1987 and ending on December 31, 1990."

3. Under Section I, Contract Clauses, add the following clause as I.2:

"I.2. Availability of Funds

Funds are not presently available for this contract. The Government's obligation under this contract is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise until funds are made available to the Contracting Officer for this contract and until the Contractor receives notice of such availability, to be confirmed in writing by the Contracting Officer."

All other terms and conditions of the subject contract remain unchanged.
