SUBJECT: NRC INSPECTION REPORT NO. 50-445/90-33; 50-446/90-33

This refers to the inspection conducted by Messrs. D. L. Kelley and A. Singh of this office on September 24-28, 1990. The inspection included a review of activities authorized for your Comanche Peak Steam Electric Station facility. At the conclusion of the inspection, the findings were discussed with you and other members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examination of procedures and representative records and interviews with personnel concerning (1) followup inspection of the personnel airlock event of September 19, 1990; (2) surveillance procedures and records; and (3) surveillance and calibration control.

Two unresolved items are identified in paragraphs 2.2 and 2.3 of the enclosed inspection report.

Based on the results of this inspection, one apparent violation was identified and is being considered for escalated enforcement action in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions" (Enforcement Policy), 10 CFR Part 2, Appendix C (1990). The apparent violation involves a failure to satisfy the Technical Specification requirement to maintain the personnel airlock operable. Based on this condition, containment integrity would not have been assured under all circumstances. No Notice of Violation is presently being issued for these inspection findings. Please be advised that the number and characterization of the apparent violation described in the enclosed inspection report may change as a result of further NRC review.
