SUBJECT: CONFIRMATION OF RESCHEDULED EXAMINATION DATES

In a recent telephone conversation between Mr. R. Laufer of NRC headquarters Operating Licensing Branch and Mr. H. Aderhold of your staff, arrangements were made for the rescheduling of two initial examinations. These examinations, which had previously been scheduled for the week of May 21, 1990, have been rescheduled for the week of October 22, 1990. Unless further notified, the written examinations will be administered on October 23, 1990, and the operation examinations will be administered on October 24, 1990.

As stated in a letter from the NRC dated February 14, 1990, you will be responsible for providing adequate space and accommodations for administration of the written examinations. You will also be responsible for ensuring that the candidates are aware of the rules and guidelines that will be in effect during the administration of the written examination.

The signed license applications and medical certifications should be submitted to the Region I Office no later than ten working days prior to the examination date. If the applications are not received in a timely manner, it is possible that a postponement of the examinations will be necessary.
