An announced inspection was conducted by Mr. Thomas Dragoun of this office on January 26-28, 1994, of activities authorized by NRC License Nos. R-37 and SNM-986. A discussion of our findings was held by Mr. Dragoun with Dr. Bernard and members of the reactor and radiation protection staffs at the conclusion of this inspection.

Areas examined during this inspection included status of previously identified items, corrective actions for a failed low-range amplifier, and implementation of the emergency preparedness program. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this review, no safety concerns were observed. However, an unresolved item, a matter about which more information is required to determine whether it is an acceptable issue, a deviation from a written commitment, or violation is identified in Section 5.4 of the enclosed report. No reply to this letter is required, but we would appreciate receiving any additional information related to the unresolved item that becomes available.
