SUBJECT: ACKNOWLEDGEMENT LETTER REGARDING IDENTIFIED CONCERN

Thank you for your letter dated February 9, 1994, in response to our January 10, 1994 letter identifying a concern pertaining to the implementation of Perry's access authorization program.

In our letter, we requested that you determine if a psychologist told an individual that it was acceptable not to follow plant procedures; what the psychologist said pertaining to following site procedures; and if the individual was given an unfavorable evaluation because of responses to the hypothetical situation in question.

Your response indicated that the psychologist stated that he had never told anyone not to follow plant procedures and that his evaluation results and recommendation were not based on the individual's answer to the situational analysis portion of the interview in question. Additionally, the psychologist could not specifically recall discussing the situational example identified in the concern.

We found your investigation to be sufficient to support your conclusions and have no additional questions regarding this matter. We request that you retain the supporting documentation for your investigation of these concerns for a minimum of one year from the date of this letter.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and your response without the enclosure will be placed in the NRC Public Document Room.
