

Schedule for Resolution of Unresolved Item 50-336/93-81-08

In a letter dated June 25, 1993,<sup>(1)</sup> the NRC Staff transmitted to Northeast Nuclear Energy Company (NNECO) Inspection Report No. 50-336/93-81. The report discussed the results of an electrical distribution system functional inspection conducted during the period between March 15 and April 2, 1993. In the Inspection Report, the NRC requested that NNECO provide, in writing, a schedule for the resolution of the 13 unresolved items identified in the subject inspection report. NNECO provided the requested schedule in a submittal dated August 24, 1993.<sup>(2)</sup> Subsequently, the NRC Staff requested that four of the unresolved items be completed earlier than the submitted schedule. NNECO submitted the revised schedule on September 22, 1993.<sup>(3)</sup> The purpose of this letter is to inform the NRC Staff of an additional change to the original schedule provided on August 24, 1993.

In the submittal dated August 24, 1993, NNECO stated that the unresolved item regarding emergency diesel generator (EDG) fuel oil consumption (unresolved item 50-336/93-81-08) would be finalized by December 31, 1993. While NNECO has completed preliminary EDG fuel oil consumption calculations, these calculations cannot be finalized due to a delay by the EDG vendor (Fairbanks Morse) in providing the vendor-approved fuel oil consumption rate. The EDG vendor is expected to provide this information by the end of the first quarter of 1994. Upon receipt of the data, NNECO will finalize the EDG fuel oil


calculations. NNECO believes that the calculations can be completed soon after receipt of the data from the EDG vendor, and will be completed not later than the end of the second quarter of 1994. Accordingly, the scheduled completion date for the EDG fuel oil consumption calculations is now June 30, 1994.

The preliminary EDG fuel oil consumption calculations demonstrate that Millstone Unit No. 2 meets the requirements delineated in Section 8.3.2.2 of the Millstone Unit No. 2 Final Safety Analysis Report and Section 9.6.2 of the NRC's original Safety Evaluation for Millstone Unit No. 2.<sup>(4)</sup> Therefore, the extension of this scheduled completion date will not have an impact on the operation of the unit, or on the health and safety of the public.

We trust that you will find this information satisfactory, and we remain available to answer any questions you may have.
