Notice is hereby given that the United States Nuclear Regulatory

Commission (the Commission) is considering approval under 10 CFR 50.80 of the proposed corporate restructuring of Commonwealth Edison Company (CECo), the owner and licensee for Braidwood Station, Units 1 and 2; Byron Station, Units 1 and 2; Dresden Station, Units 1, 2, and 3; LaSalle County Station, Units 1 and 2: Nuad Cities Station, Units 1 and 2; and Zion Station, Units 1 and 2.

By letter dated January 31, 1994, Sidley and Austin, acting as counsel to CECo, informed the Commission that the Board of Directors has proposed a corporate restructuring plan to be presented at the May 10, 1994, shareholders meeting. If a majority of the shareholders approve the plan, CECo will become a wholly-owned subsidiary of a new holding company, CECo Holding Company,

9403100080 940304 PDR ADDCK 05000010 effective on or about July 1, 1994. CECo would remain as holder of the licenses for the aforementioned facilities. If the plan is approved, the common stock of CECo will be converted on a share-for-share basis into the common stock of the holding company, and there will be no effect upon the management, operation, and financing of the CECo nuclear facilities.

Pursuant to 10 CFR 50.80, the Commission may approve the transfer of control of a license, after notice to interested persons. Such action is contingent upon the Commission's determination that the holder of the license and the transfer of such control is otherwise consistent with applicable provisions of law, regulations, and orders of the Commission.
