Gentlemen:

This refers to the inspection conducted by Messrs. J. A. Dyer and A. G. Wagner of this office on August 9-12, 1978, of activities authorized by NRC Construction Permit No. CPPR-83 for the McGuire Nuclear Station Unit No. 1 facility, and to the discussion of our findings held with Mr. M. McIntosh by telephone conversation on August 14, 1978.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

During the inspection, it was found that certain activities under your license appear to be in noncompliance with NRC requirements. This item and references to pertinent requirements are listed in the Notice of Violation enclosed herewith as Appendix A. This notice is sent to you pursuant to the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Section 2.201 requires you to submit to this office, within 20 days of your receipt of this notice, a written statement or explanation in reply including: (1) corrective steps which will be taken to avoid further noncompliance; and (2) the date when full compliance will be achieved.
