This refers to the routine safeguards inspection conducted by Mr. G. C. Smith of this office on November 15-19, 1982 at Beaver Valley Power Station, Unit 1, Shippingport, Pennsylvania of activities authorized by NRC License No. DPR-66 and to the discussions of our findings held by Mr. Smith with Mr. F. Bissert of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. 
