SUBJECT: RECIPROCITY

On February 22, 1994, the Texas Department of Health, Bureau of Radiation Control (BRC) notified NRC of the issuance of Emergency Cease and Desist and Impoundment Order No. 9464710 to ATL Laboratories, Inc. (ATL), Texas License No. L03924. 10 CFR 150.20(a) of NRC regulations states, in part, that a general license is granted to any person holding an Agreement State specific license, provided that the license does not limit activities to individual installations or locations. Under the provisions of the BRC Order, ATL's Agreement State license was restricted to storage of licensed material at 2371 NW Dallas Street, Suite 200, Grand Prairie, Texas, thus making ATL ineligible for a general license to work in NRC jurisdiction.

On February 23, 1994, BRC issued Rescission Order No. 94649R0 rescinding the February 22, 1994, Order, thus restoring ATL's eligibility to work in NRC jurisdiction. As discussed with you by Mr. William L. Fisher of this office on March 1, 1994, ATL's Texas license is again recognized as valid for work in Oklahoma, as described in the REPORT OF PROPOSED ACTIVITIES IN NON-AGREEMENT STATES (NRC Form 241) submitted by you on January 20, 1994. As stated in our January 25, 1994, letter from Ms. Christi Hernandez to you, that Form 241 may be modified throughout 1994 without fee by notifying this office of the necessary changes.

The matter of ATL's having started work in NRC jurisdiction before submitting the January 20, 1994, Form 241 is still being reviewed. We will correspond with you at a later date regarding that matter.
