This refers to the routine safety inspection conducted by Mr. D. J. Collins of this office on October 18-22, 1982, at Indian Point Station, Buchanan, New York, of activities authorized by NRC License No. DPR-26 and to the discussions of our findings held by Mr. Collins with Mr. C. W. Jackson, Vice President, Nuclear Power at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.
