In the NRC response beginning on page 6 of the notice, insert a new sentence after the first sentence which reads, "Spent fuel management and funding plans submitted in compliance with the amended §50.54(bb) need not cover spent fuel while it is being stored in an ISFSI in compliance with Part 72".
