This letter conveys the results and conclusions of the Operational Safeguards Response Evaluation (OSRE) conducted by the NRC's Office of Nuclear Reactor Regulation at the River Bend Nuclear Generating Station from December 6 through 9, 1993.

The OSRE team was composed of NRC personnel assisted by personnel from the U.S. Army. One purpose of the OSRE program is to evaluate a licensee's ability to respond to an external threat by focusing on the interactions between operations and security in establishing priorities for protection of equipment and on the defensive strategies used. The OSRE also includes a safety/safeguards interface review to assure that safeguards measures do not adversely affect safe operation of the facility.

The OSRE conclusions are documented in the enclosed report (Part I, Operational Safeguards Readiness Review; and Part II, Safety/Safeguards Interface Review). This enclosure, which contains safequards information of a type specified in 10 CFR 73.21, will not be placed in the Public Document Room, and must be protected against unauthorized disclosure.

The high quality of the drills, exercises, and demonstrations observed by the team and the results of interviews conducted by the team indicated an excellent contingency response capability at River Bend. The team also concluded that effective provisions were in place to assure that safeguards measures did not adversely affect the safe operation of the facility.
