SUBJECT: NRC INSPECTION REPORT NOS. 50-334/94-02 AND 50-412/94-02

This refers to the inspection conducted by Messrs. L. Rossbach, P. Sena, and S. Greenlee of this office from January 4 to February 7, 1994. The inspection included a review of activities authorized for the Beaver Valley Power Station in Shippingport, Pennsylvania. At the conclusion of the inspection, the findings were discussed with Messrs. D. Sperry and G. Thomas, and other members of your staff.

Areas examined during the inspection are identified in the report. The inspection consisted of document reviews, interviews, and observation of activities important to public health and safety. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements.

Overall, the plants were operated safely and conservatively. However, our inspectors and your staff identified some violations of requirements, in that a person did not frisk after leaving a radiologically controlled area and a chemistry analysis procedure was not followed completely. These violations are not being cited because of their minor safety significance and the adequacy of your corrective actions.

No reply to this letter is necessary. Your cooperation with us is appreciated.


