Enclosed is the report of the February 14-17, 1994 inspection, by Mr. J. Laughlin and others, of the Beaver Valley Power Station emergency preparedness full-participation exercise that began on February 15, 1994. Preliminary inspection findings were discussed with you and members of your staff at the conclusion of the inspection.

Overall, the onsite response was very good and demonstrated that the emergency plan and procedures for the facility met NRC requirements and that the plant staff is capable of implementing them. Exercise strengths included Emergency Director command and control, technical support from the Technical Support Center, and liaison with State representatives in the Emergency Operations Facility. No exercise weaknesses were identified. Significant performance improvement was demonstrated in the implementation of protective measures for field teams, therefore, a previously identified item in this area was closed.
