SUBJECT: TELEDYNE ENERGY SYSTEMS  
(QUALITY ASSURANCE PROGRAM APPROVAL NO. 0397)

This is to inform you that the termination of the Quality Assurance (QA) Program Approval No. 0397 for Teledyne Energy Systems (Teledyne) has been completed (Enclosure 1). Please note that the termination process has taken an unusually long time because a number of other issues, requiring further actions, had to be accomplished first.

I have enclosed, for your reference, the history of the termination. Specifically, please note that in my memorandum to you dated September 30, 1993 (Enclosure 8), I informed you that Teledyne requested that their QA Program Approval No. 0397 be terminated effective September 21, 1993 (Enclosure 9). In that letter, Teledyne also requested that two of their Certificates of Compliance (COCs) be terminated and that other COCs be transferred to the U.S. Department of the Navy and the U.S. Department of the Air Force. The transfer of the COCs was recently completed (Enclosures 2 through 5) and, thus, we terminated Teledyne's QA Program Approval.

As previously mentioned in my memorandum to you (Enclosure 8), in our view Teledyne provided timely notification to the U.S. Nuclear Regulatory Commission of their desire to terminate their QA Program Approval. Now that the termination has been completed, we recommend that you give similar consideration to the issue of FY 1994 fees for Teledyne.
