10 The position of control rod 10-31 was immediately verified by moving the rod

to an operable reed switch position. It was determined that the superimposed "3"

position was caused by a ground on the RPIS probe. The position indication will be

restored to normal during the next Unit 1 shutdown. Due to the large number of reed

switches in use on both Units (14, 248 read switches), this is considered an isolated
