Gentlemen:

This refers to the inspection conducted by Mr. C. R. McFarland of this office on August 29-31, 1978, of activities authorized by NRC Construction Permit Nos. CPPR-78, CPPR-114 and CPPR-115 for the North Anna Power Station Unit 2, 3 and 4 facilities, and to the discussion of our findings held with Mr. P. G. Peery at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Within the scope of this inspection, no items of noncompliance were disclosed.

We have examined actions you have taken with regard to previously identified enforcement matters and unresolved items. The status of these items is discussed in the enclosed report.

In accordance with Section 2.790 of the NRC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room. Inspection Summary

Inspection on August 29-31, 1978 (Report Nos. 50-339/78-24, 50-404/78-7 and 50-405/78-7)

Areas Inspected: Routine, unannounced inspection of licensee action on previous inspection findings, 10 CFR 50.55(e) items, IE Bulletins and preservice inspection-observation of work and review of records. This inspection involved 70 inspector-hours on site by four NRC inspectors.
